A salesperson can change dealerships during the licensing year provided that a change of employer notification form and fee is submitted to the Board. It is unlawful for such a salesperson to act as a motor vehicle salesperson or power sports salesperson until a new license is procured. 1.

Up to twenty calendar days from start to finish is allowed for an off-premise permit for the National Western Stock Show, the Colorado State Fair, the Greeley Stampede, or the Denver Auto Show. Once permit is approved, the approved permit must be posted for inspection at the sale location. Consecutive permits for the same location are not allowed.

Dealer Licensing in Colorado You ' ll need to apply for a dealer/wholesaler license with the Colorado Department of Revenue ' s (DOR) Auto Industry Division (AID) if you plan to sell OR lease at least 3 vehicles during 1 calendar year at the same address. A dealer sells vehicles to the general public, while a wholesaler sells cars to dealers.

The Colorado sales tax license (in other parts of the country, may be called a reseller ' s license, a vendor's license or a resale certificate) is for state sales tax and any state-collected county, city and special district taxes that the Colorado Department of Revenue collects and distributes back to local governments.

Obtain \$50,000 Colorado auto dealer bond. Pay your licensing fee – \$519 for the July 1, 2016 – June 30, 2017 licensing period. A number of additional documents may also be requested by the Division as you apply, depending on your particular case. These are:
