In its general recommendation No. 28, the Committee on the Elimination of Discrimination against Women indicates that "the term 'gender' refers to socially constructed identities, attributes and roles for women and men and society's social and cultural meaning for these biological differences resulting in hierarchical relationships between women and men and in the distribution of power and rights favouring men and disadvantaging women.

The Equal Pay Act (EPA) of 1963 is a federal law which prohibits pay

discrimination on the basis of gender. The EPA is an amendment to the Fair Labor Standards Act and was enacted to rectify the pay inequity that existed (and still persists today) between men and women who perform the same job duties. Title VII of the Civil Rights Act was passed one year after the EPA, and expanded workers' rights with respect to discrimination in the workplace.
