This Directive now requires Member States to assess if all water courses and coast lines are at risk from flooding, to map the flood extent and assets and humans at risk in these areas and to take adequate and coordinated measures to reduce this flood risk.

Flood mapping is a crucial element of flood risk management. Directive 2007/60/EC on the assessment and management of flood risks will require Member States to prepare two types of maps by 2013 (art 6) : Flood hazard maps, showing the extent and expected water depths/levels of an area flooded in three scenarios, a low probability scenario or extreme events, in a medium probability scenario (at least with a return period of 100 years) and if appropriate a high probability scenario.

The European Union is addressing flood risk through the Floods Directive. Countries are required to draw up flood risk maps by 2013 and establish flood risk management plans focused on prevention, protection and preparedness by 2015. In April 2013 the European Commission adopted a Communication on an ‘ EU strategy on adaptation to climate change ’ which aims at contributing to a more climate resilient Europe.
