## HIPAA Privacy Rule

The HIPAA privacy guidelines apply to any entity that may have access to information about a patient. Each entity has to implement the necessary precautions to prevent the risk of harm to a patient's finances or reputation if there was to be an unauthorized disclosure of PHI.

## HIPAA Privacy Guidelines - HIPAA Journal

New HIPAA Regulations in 2020. OCR issued a request for information in December 2018 asking HIPAA covered entities for feedback on aspects of HIPAA Rules that were overly burdensome or obstruct the provision of healthcare, and areas where HIPAA updates could be made to improve care coordination and data sharing.

## HHS proposes changing HIPAA privacy rules

The Health Information Technology for Economic and Clinical Health (HITECH) Act requires HHS to periodically audit covered entities and business associates for their compliance with the HIPAA Rules. OCR conducted audits of 166 covered entities and 41 business associates and has notified these organizations of OCR ' s findings.
