The Chicago/Turabian style of citing sources is generally used when citing sources for humanities papers, and is best known for its requirement that writers place bibliographic citations at the bottom of a page or at the end of a paper.

There are two ways of using a quote in an essay MLA. The in-text method requires only the page number of the source used in parentheses at the end of the quote. The parenthetical one requires you to include both the author's last name and the page number. Using a Direct Quote

When using a direct short quote for APA citation of journal articles, you must list the author, the year of publication, the page number (s), and use quotation marks.

Cite by listing the article's author, putting the title of the article in quotations marks, and italicizing the periodical title. Follow with the date of publication. Remember to abbreviate the month. The basic format is as follows:

Cite articles in online scholarly journals that also appear in print as you would a scholarly journal in print, including the page range of the article. Provide the URL and the date of access.

Include an in-text citation when you refer to, summarize, paraphrase, or quote from another source. For every in-text citation in your paper, there must be a corresponding entry in your reference list. APA in-text citation style uses the author's last name and the year of publication, for example: (Field, 2005).

Citing Magazine, Journal, and Newspaper Articles 1 Start with the author's name. List the author's name with the last name first, followed by a comma, then the author's first and middle initials (if the middle initial is available).

Include the author and year for a standard parenthetical citation. At the end of any sentence in which you mention or paraphrase the source, add a parenthetical citation with the author's last name, followed by a comma, then the year the article was published. Your parenthetical citation goes inside the sentence's closing punctuation.

Online News Article Note: The format for this type of source depends on whether your source comes from a site with an associated newspaper. If the source does come from a site with an associated newspaper, leave the title of the article unformatted, but italicize the title of the newspaper. Lastname, F. M. (Year, Month Date).

Basic format for an APA journal citation

The article title appears in plain text and sentence case, while the journal name is italicized and in title case (all major words capitalized). When viewing a journal article online, the required information can usually be found on the access page.

Separate the page numbers with a dash and place them next to the author name within the citation, e.g., (Jacobs, 2010, pp.231-234).

Start by listing the author's last name and first initials, followed by the date of publication in parentheses. Provide the title of the article, but only capitalize the first letter of the title. Next, list the journal or periodical and volume number in italics, followed by the issue number in parentheses.
