Before a student can analyze a legal issue, of course, they have to know what the issue is. Thus, logically, step one in the IRAC methodology is to identify the issue (I). Step two is to state the relevant rule(s) of law that will apply in resolving the issue (R). Step three is to apply those rules to the facts of the question—that is, to 'analyze' the issue (A).

IRAC Method of Legal Writing Definition and Examples

The IRAC method is a framework for organizing your answer to a business law essay question. The basic structure is: I ssue, Rule, Analysis, and Conclusion . Using this simple framework for structuring your answer will ensure that you have written a complete answer. Issue Begin your answer by stating the issue presented by the essay question. Sometimes the question will provide the issue for you.

IRAC, as you may well know, is a method for answering exam questions. It stands for Issue, Rule, Analysis, Conclusion. The idea of IRAC is that students go through an exam fact pattern, spot as many issues as they can, state the rules of law, apply the law to the facts, then arrive at conclusions. The problem is that many students do this in a sloppy manner and lose a lot of points in the process.
