You receive Code A Supplemental Security Income (SSI Living Alone) OR your income must be below 150% of the federal poverty guidelines. Applications for regular HEAP benefits will be accepted beginning around November of the year. California also provides Weatherization service for those who qualify.

Most states, such as New Hampshire, look at the gross income of an entire household, which is a household's total pay before any taxes or deductions are taken into account.

Other than these two specific exceptions, OCS lacks authority to waive federal LIHEAP requirements, regarding income eligibility, administrative costs, etc. However, LIHEAP grantees can change their LIHEAP income eligibility cut-off if they had originally set them below the federally permitted maximum—the greater of 150% of the Federal Poverty Guidelines or 60% State Median Income (SMI).
