Order PB 1109, National Pesticide Applicator Certification “Core” Manual. Category 1, Agricultural Pest Control —If you apply restricted-use pesticides in the control of plants, whether woody or herbaceous, to planted and/or cultivated crops or to land otherwise used in agricultural production, you need to be commercially certified in this category.
