Rule Summary: The Used Car Rule, formally known as the Used Motor Vehicle Trade Regulation Rule, has been in effect since 1985. It requires car dealers to display a window sticker, known as a Buyers Guide, on the used cars they offer for sale. The Buyers Guide discloses whether the dealer offers a warranty and, if so, its terms and conditions, including the duration of the coverage, the percentage of total repair costs the dealer will pay, and which vehicle systems the warranty covers.

Used Car Rule | Federal Trade Commission  
The Buyers Guide must be displayed prominently and conspicuously on or in a vehicle when a car is available for sale. This means it must be in plain view and both sides must be visible. You can hang the Guide from the rear-view mirror inside the car or on a side-view mirror outside the car.

Enforced by the Federal Trade Commission, the Used Motor Vehicle Trade Regulation Rule – most people call it the Used Car Rule – requires dealers to display on used cars a window sticker called a Buyers Guide that contains warranty and other information. The Used Car Rule has been in place since 1985.

If a car is covered by the state's used car warranty law or another warranty, then the dealer must check the "dealer warranty" box on the Buyers Guide.

The guide, which is part of the sales contract, protects consumers by overriding any conflicting clauses or statements in the regular contract.

4 Things to Understand About "The Used Car Rule"  
The Buyers Guide should be displayed on the vehicle so customers can see the front and back of the Buyers Guide. It can be displayed in a window, hung from the rear view mirror, placed under a windshield wiper, or even hung from an outside mirror.
